Objetivos de aprendizagem (conhecimentos, aptidões e competências a desenvolver pelos estudantes)

Populismo e partidos e movimentos populistas sempre existiram e foram objeto de estudo científico e de debate crítico. Hoje são (de novo) um espetro para a democracia e, na Europa, uma ameaça para o projeto europeu. Os objetivos centrais são compreender por que razão o populismo tem adquirido fulgor na última década ou mais além, na Europa e noutras geografias, e qual o impacto desse fenómeno nos sistemas políticos e, especificamente, nos sistemas de partidos.

5. O impacto do populismo e dos partidos e movimentos populistas nos sistemas partidários

Os conteúdos programáticos pretendem assegurar a conciliação de momentos de recolha de dados e de informação sobre os temas relevantes e momentos de generalização e teorização.

Funciona-se em regime de seminário, com apresentação de temas por parte do docente e apresentação de trabalhos nas aulas pelos mestrandos, com discussão subsequente.
