Learning objectives: To understand the origins of juridical and political theories on international relations in the Modern and Contemporary Ages (from the 15th century to the 21st century), students should learn and develop their own critical approach to the paradigms of international relations and their connection with the history of the Law of Nations / International Law, from the maritime expansion and the development of modern State to our day. Special attention will be dedicated to: State and sovereignty; the law of international relations; war and peace; international organizations; the protection of human rights; the phenomenon of global terrorism; the challenges of globalization. The syllabus consolidates the evolution of international relations from the early modern age to our day. The concepts and structures to be analysed according to a historical-juridical method allow to critically understanding the origins of contemporary forms of political and legal organization of international relations.
