Os Acordos Comerciais Preferenciais

Todos os membros da Organização Mundial do Comércio (OMC) são partes pelo menos de um acordo comercial preferencial, existem acordos comerciais preferenciais em que as partes são elas próprias outros acordos comerciais preferenciais (por exemplo, o acordo concluído entre a Associação Europeia de Livre Comércio (EFTA) e a União Aduaneira da África Austral (SACU) e muitos membros da OMC participam em vários acordos comerciais preferenciais ao mesmo tempo. No dia 1 de Janeiro de 2019, por exemplo, a União Europeia participava em 40 acordos comerciais preferenciais notificados à OMC; o Chile em 30; Singapura em 24; a Turquia em 23; o Japão em 16; e a China em 15. Atendendo à sua importância nos dias de hoje, faz todo o sentido estudar e analisar esta “Preferential Trade Agreement pandemic” ⁽¹⁾ e verificar se, efetivamente, os acordos comerciais preferenciais representam a melhor solução do ponto de vista do bem-estar mundial e se colocam em causa o papel dos acordos da OMC enquanto instrumento de liberalização do comércio internacional ou se o complementam.
