**Course: American Housing Law & Policy** 

Professor: Monica Teixeira de Sousa

This intensive 5-day course introduces Portuguese law students to American housing law and policy, and the historical causes and development of America's contemporary housing crisis. Through a comparative analysis of the American experience, students will gain valuable insights for addressing Portugal's own housing challenges, including rising urban housing costs, gentrification, and the balance between tenant protections and housing development.

#### **Course Overview:**

This condensed 5-day course (Monday-Friday, 2 hours each day) provides Portuguese law students with an intensive introduction to American housing law and policy. The course is designed not only to convey substantive knowledge about housing law but also to introduce students to American legal education methods. Each day features landmark cases, key legal doctrines, statutory excerpts, and examples of grassroots organizing for housing justice. The professor, who was born in Portugal, will encourage students to engage in a comparative analysis of the U.S. and Portuguese legal systems, thereby deepening and enriching all participants' knowledge of their respective systems. The course takes a critical approach, using Catherine Bauer's *Modern Housing* as a framework to evaluate the American model and consider the alternative approaches that may be more relevant to the Portuguese context.
